This year the conference will be held on Saturday, May 9 at the Camden Public Library from 9:30

a.m. to 2:30 p.m. Registration (limited to 75 people) is \$12.50 per person, which includes lunch. This year s featured speaker will be genealogist Carol McCoy who will speak on Creative Ways to Solve Genealogical Problems. Other speakers include Helen Shaw, Regent of the Lady Knox Chapter NSDAR, who will discuss the chapter s work to locate and document all Revolutionary War patriot graves in Knox County, Candace Kanes, curator of the Maine Memory Network, who will give an update of the Network s activities, and Kevin Johnson, photo archivist for the Penobscot Marine Museum, who will talk about the 40,000 glass plate archives of the Eastern Illustrating and Publishing Company of Belfast. His talk will focus on glass plates pertaining to the towns in Knox, Waldo, and Lincoln County that are represented at the conference.

Victor Gallo of Lisbon, Portugal, contacted OBBFHA regarding the **Hahn family** of Fabrikschleichach in the Steigerwald area of Bavaria. He is a descendant of Hans Michael Hahn who emigrated to Portugal between 1740-1750. [Gallo is the Portugese translation of Hahn.] He believes that other members of the Hahn family came to Waldoboro, as they came from the same region. Bob Saquet wrote inquiring about the burial place of **Elizabeth Kinsell (Kinsel or Kuentzel) Noble** who was born in Waldoboro and died in Mansfield, MA. Her parents are interned in the churchyard of the Old German Church and upon her death her remains were supposed to be transported to Waldoboro for burial. Mr. Saquet is inquiring if anyone knows of her burial place. Additionally, he is seeking any information about the "**Fennelly Fund**" which was created by Elizabeth Fennelly Kinsell for the relief of descendants of the original German settlers, preference given to widows. She also donated \$5000 dollars to a fund dedicated to constructing a new wall around the "Old German Cemetery." Maps, maps, maps

One can never have enough maps for the area(s) in which one s ancestors lived. Early in the second decade of the nineteenth century, surveyors fanned out across Lincoln County to prepare maps of land holders as part of the process of settling land claims. Maps from this era of particular interest to OBBFHA members are for the towns of Waldoborough, Nobleborough, Jefferson, and Bristol. Maps for Edgecomb, Boothbay, and Newcastle were also prepared during the same time period. All these maps show the names of settlers and their lots.

You can now purchase a full size copy of the 1815 map of Waldoboro (about 2' x 6'). The original map (prepared by James Robinson) is in the archival vault in Wiscasset and has been digitally scanned by the county. To purchase a copy of this map, send your request to the Lincoln County Registry of Deeds, PO Box 249, 32 High St, Wiscasset, ME 04578. Include a check for \$8.00 (\$5 for the map and \$3 for postage & handling) made out to the Registry of Deeds. Map copies are sent folded in a large envelope. You may also stop by the courthouse to purchase a map, but be aware that it may take some time to make the copy. The office is open Monday through Friday, except holidays, from 8:00 a.m. to 4:00 p.m. The phone numbers are 207-882-7431 and 207-882-7515.

Maps of settlers lots for other Lincoln County towns are in the special collections of the Massachusetts State Archives. Four of the maps are oversized:

Jefferson (#1766) surveyed by James Robinson Bristol (#1768) surveyed by William McClintock Edgecomb (#1772) surveyed by Stepehn Parsons Boothbay (#1773) suveyed by Daniel Rose

Settlers lots for Newcastle were surveyed in 1811 (#1739; plan located in 3rd series, vol. 21, p 6). Lots in Nobleborough were surveyed in 1813 by Ephriam Rollings (#1758; plan located in 3rd series, vol. 48, p. 5). These maps are smaller and have been microfilmed.

Unfortunately, due to their fragile condition, only the map for Newcastle can be scanned. It may be possible to scan the maps for Jefferson and Nobleborough, but the suggestion from the archivist was to have people come to the Historical Society and take (non-flash) photos of the maps. If several people want scans of the maps, the suggestion was to make one disc and have prints made by an outside agency from that disc. Another source for Nobleboro maps is the Nobleboro Historical Society which has both the 1813 map and an 1857 map available in a 19" x 25" format for \$5.00 each. Eastern Lands Papers, Massachusetts State Archives

The above mentioned maps in the collection of the Massachusetts State Archives are companion pieces to the Eastern Lands Papers, a collection of some 30 cubic feet, covering the sale and development of land in Maine and the settlement of land disputes in Maine between 1717-1860.

Detailed information about this collection can be seen on the state archives website at: http://www.sec.state.ma.us/arc/arcpdf/eastland.pdf. The forty pages of descriptive text covers history (pp. 3-8), chronology (pp. 8-9), and records. The records section is divided into three parts:

- I. Sale and Development of Public Lands in Maine (pp. 10-20)
- II. Disputed Lands in Maine (pp. 21-31)
- III. Separation of Maine (pp. 32-40)

Of particular interest to OBBFHA members are several collections within part II of the records. Specifically:

EA 5 Commissioners to Quiet Settlers on the Waldo Claim, 1797-1800

This deals with the dispute between settlers brought by General Samuel Waldo to the Waldo Patent (Claim) between the east side of the Muscongus River and Penobscot Bay and his son-in-law General Henry Knox after the Revolutionary War. The disputes were largely settled by 1796. The Commissioners went to the patent in 1797, received references from settlers, and appointed James Malcolm, John Harkness, and Robert Huston as surveyors to identify settler lots and note land conditions.

Series with this agency:

83x Certificates of agreement for quieting settlers, 1797-1800 (2 vols): legal documents between Henry Knox and settlers without title in the Waldo Patent. Arranged by town and then by individual (name index at the beginning of each volume). *Information*

includes the name of the settler, date moved onto land, town where land was located, and whether the property had been transferred to another person.

854x Commission Files 1763 - 1799 (1 document box): includes depositions regarding the arrival of certain settlers.

EA9 Commissioners to Investigate Disturbances in Lincoln County, 1803-1811

This deals with disputes near the Damariscotta River between settlers and non-resident proprietors. The commissioners met first in Wiscasset in 1 May 1811 and later in Newcastle, Bristol, and Nobleborough through 10 May. To avoid lengthy court proceedings, the non-resident proprietors relinquished their claims in exchange for land elsewhere in Maine.

Of particular interest here is the series:

90x Evidence Presented to Commissioners, 1803-1811 (1 document box): Sub-series 2 includes *Deeds, patents, wills and depositions presented before the commissioners by attorneys on behalf of various claimants.* [Apparently copies were made of these documents which were then held by the commissioners; *in 1885-1886 they were removed from this collection and incorporated into the Massachusetts Archives Collection, series 45x.*]

EA10 Commissioners for Determining Rights of Claimants to Lands in Lincoln County, 1811-1813

Commissioners here ...authorized a survey showing nonresident claims; received testimony from nonresident proprietors and town settlers; received submission, deeds of release, and accompanying powers of attorney from nonresident proprietors....

Of particular interest in this series:

91x Administrative files, 1810-1813 (2 document boxes): files presented to the commissioners documenting claims to lands in Bristol, Edgecomb, New Castle, Nobleborough, Waldoborough, Jefferson, and Boothbay. There are four sub-series in this collection of which two are noted here:

Sub-series 3: Claims of nonresident proprietors, which include copies of wills and deeds, genealogies, title abstracts, and other papers to substantiate rights to lands under Brown, Tappen, Drowne, Brown/Pierce and Pemaquid claims.

Sub-series 4: Claims of settlers, records provinf title to contested lands and showing length of residency, including lists of settlers in the towns of Palermo, Putnam, and Jefferson.

- 92x Deeds of Release to the Commonwealth, 1812 (1 document box): deeds transferring title from the nonresident proprietors to the Commonwealth. Towns included were Boothbay, Bristol, Edgecomb, Jefferson, Newcastle, Nobleborough, and Waldoborough.
- EA 11 Commissioners Appointed to Give Deeds to Settlers in Lincoln County, 1813-1819

 These commissioners followed up on the work done by the commissioners under EA 9 and EA 10. Under these commissioners, each settler received a clear title for up to 200 acres of his property (including improvements) for a nominal amount of money. Settlers were divided into two groups: those who resided on their property prior to January 1, 1789, and all other

settlers. The first group was allowed to purchase their land for \$5.00 per one hundred acres. The second group paid \$.30 per acre.

Maps created under this commission were those for Boothbay, Bristol, Edgecomb, Jefferson, Newcastle, Nobleborough, and Waldoborough.

EA 13 Commissioners to Quiet Settlers in Waldoborough This deals with the settlement of land of the Plymouth Company.

Series 86x Certificates of agreement for quieting settlers, 1803-1804 (1 vol): contains legal documents completing the process of land sales between Henry Knox and settlers. Includes name of the settler, exact description of the land, name of the surveyor, amount owed the proprietor and the date paid.

Series 853 x Commission files, 1803-1804 (2 folder): contains the *November 1803 petition* from Waldoborough settlers to the commissioners asking to be deemed eligible for quieting.

Waldoboro article

Membership
