Recent additions for Maine & Massachusetts to Familysearch.org

Many thanks for Joe Anderson, MGS editor, for the following information and instructions.

Familysearch has added a database of Massachusetts deeds to its website. To access these records go to www.familysearch.org

- 1. press "search" at the top of the page
- 2. scroll down to the bottom & press "United States"
- 3. press "Massachusetts" on the list on the left side of the page
- 4. click on "Massachusetts, Land Records, 1620-1986"

There are another 17 databases for Massachusetts including vital records, passenger lists, & naturalization records.

Familysearch has also been adding probate records for Maine counties (several counties done) and is starting to add deeds (Aroostook & Piscataquis counties so far) for a total of 21 databases, including vital records and cemetery records. The above directions can be used to see databases for every state; simply click on the state of interest in #3.

Update on LD 274, the MOCA cemetery bill

LD 274, *An Act to Preserve and Protect Ancient Burial Grounds and Burial Grounds in Which Veterans Are Buried*, was passed by the state legislature and has been sent to the governor for his signature. Assuming he signs it or allows it to pass without his signature, it will take effect in September, 90 days after the legislature adjourns.

This bill separates ancient burying grounds (those established on private property before 1880) from public burying grounds. Under this new law it is no longer necessary for a veteran to be buried in an ancient burying ground for the property owner to be required to care for it or for a town to step in and care for it if the property owner does not or can not. Many ancient burying grounds are already cared for by family members or cemetery associations; many towns also care for ancient burying grounds within their borders. This new law allows the town to appoint a caretaker for an ancient burying ground while maintaining oversight and continuity of care over time.

The bill also removes the requirement that only the graves of veterans who served in a time of war be cared for in public burying grounds. Again, many towns and organizations already place flags and care for the graves of **all** veterans, not just those who served during a time of war.

The bill was amended by the Committee on State and Local Government to increase the level of care required for veterans graves in public burying grounds. The suggestions for increased care come from the report of the Stakeholder Group for the Development of a Plan for the Inventory and Proper Care of Veterans' Graves which was presented to the State and Local Government Committee by Peter Ogden, Director, Bureau of Maine Veteran's Services, at the public hearing for LD 274 in March.

The bill was further amended by Senator Dawn Hill, chair of the Appropriations Committee, on June 27th, by adding a mandate preamble immediately following the bill title. This preamble in effect said the bill was an unfunded mandate and thus required a two-thirds vote of the House and Senate to pass into law. The bill was passed with both amendments later that day.

Jean Lawrence wins short story competition

She waged an unsuccessful ten year court fight against Henry Knox for the title to her land and home. Despite losing in court, she managed to purchase the property from Knox's heirs. One of Sedony's grandchildren was Augustus Welt, a famous 19th century shipbuilder, businessman and civic leader. Sedony personified the faith, hard work and determination of the early residents of Waldoboro. Congratulations Jean! Thanks for bringing a remarkable ancestor to life!
